The Board of Postsecondary Institutions (JIP in Spanish) through the Office of Registration and Licensing of Educational Institutions (ORLIE in Spanish) certifies that the University of Puerto Rico has a Renewal License granted by the Puerto Rico Council on Education (CEPR in Spanish) through Certification Number 2018-210. This License was approved for the following institutional units: Río Piedras Campus, Mayagüez Campus, Medical Sciences Campus, University of Puerto Rico at Humacao, University of Puerto Rico at Cayey, University of Puerto Rico at Arecibo, University of Puerto Rico at Ponce, University of Puerto Rico at Bayamón, University of Puerto Rico at Aguadilla, University of Puerto Rico at Carolina, University of Puerto Rico at Utuado.

The validity of this Renewal License is for five (5) years, however, in accordance with Section 16.5 of the *Regulations for the Granting of License to Institutions of Higher Education in Puerto Rico*, No. 8265 of October 9, 2012, by which the license was approved, the license remains in force. This section provides that:

If a license expires while the renewal procedures are normally being carried out, without negligence or fault on the part of the institution, the Council shall consider that the license continues to be in force under the conditions laid down until the procedure is completed. Once the procedure is completed, the determination made by the Council on this request will apply.

After the 2018 License, through Certification Number 2022-162, the Board approved the institutional unit Bayamón Correctional Complex / Northern Region Penal Institution Annex 292 and Bayamón Women's Correctional Complex, Puerto Rico, attached to the Río Piedras Campus.



The Office of Registration and Licensing of Educational Institutions is evaluating the Application for Renewal of the License submitted by the Institution under the *Regulations for the Licensing of Postsecondary Education Institutions in Puerto Rico*, No. 9272 of 2021, in force at this time.
